DIRECTIONS FOR USE: GENERAL

AVITHOR GUANAWAY is suitable for use in and around Commercial, Industrial, Rural and Residential Buildings. AVITHOR GUANAWAY is a heavy duty alkaline cleaner disinfectant for high risk areas. It is ideal for use to control micro-organisms associated with the clean-up of bird waste. Cleaning operators run the risk of disease resulting from inhaling micro-organisms associated with bird areas e.g. Psittacosis, Histoplasmosis, Salmonellosis, Gastroenteritis (caused by *e-coli*) and other serious diseases.

AVITHOR GUANAWAY passes BS6471 against *e-coli*. By treating with AVITHOR GUANAWAY before, during and after the removal of bird wastes, the risk in areas where birds are known to have been present is greatly reduced. AVITHOR GUANAWAY is a powerful alkaline cleaner degreaser which also neutralises the acidic by-products associated with bird droppings. This reduces corrosion to stone work and increases safety by removing the slippery greasy waste.

Heavy duty cleaning and disinfecting. Removal of droppings. Treatment of dead birds, collected nests and other such materials. Cleaning of contaminated equipment e.g. boots, goggles, gloves, spray tanks, shovels and bins.	50 mL / L	Dilute with clean water and spray over droppings before the clean-up operation commences. During the operation, spray solution on to each fresh layer of droppings as it is exposed, to keep dust down and kill micro-organisms. Dilute with clean water and spray over droppings before the clean-up operation commences. Spray or wash items with diluted product.
